Dear Out of State & International Residential Students:

I am writing to share updated move-in information for you. As you might have heard by now, New York State has created an ever-growing list of states from where individuals who enter from those states must be quarantine/isolate for 14 days when coming to New York. In addition, the Center for Disease Control (CDC) continues to ask those travelling internationally to quarantine for 14 days upon return to the United States. Obviously, as the state list keeps growing and guidelines change, and as we are trying to ensure compliance with the law and provide students with a schedule to return, we have to adapt.

So, in accordance with that law and to make planning for students as straight-forward as possible, the College is requiring all non-New York State residents to return to campus and complete a 14-day quarantine prior to your anticipated campus obligations. During this period of quarantine, we will provide you with meals delivered to your room and are designing a process for you to get outside food delivery if you so choose. It is important to note that during this period of quarantine, you will have to stay in your assigned space. We will be scheduling on-campus COVID-19 testing for you, and will give you more information about this shortly.

For student athletes who are participating in a fall sport, please know that Athletics is working hard to get clarification from the NCAA on what the fall season will look like. To that end, there may be some changes to this schedule and we will communicate those as soon as we know for sure.

We know that this is an inconvenience and a challenge, but please know that the Daemen community is here with you throughout it all. You will have access to all of our campus support systems virtually, just as you did when you were home.

Please review the dates below to determine when you need to return to campus. You will be sent specific instruction at a later date regarding signing up for required COVID-19 testing.
