

Emergency Financial Aid to Students under the American Relief Plan

Quarterly Report December 31, 2021

The following report is submitted by Daemen College, as a recipient of Higher Education Emergency Relief Funds (HEERF), in compliance with Coronavirus Response and Relief Supplemental Appropriations Act (ARP), 2021 Supplemental Agreement for an Award under Section 314 (a)(2) and as outlined in Section 18004(e) of the CARES Act as our quarterly report due January 10, 2022 to the Secretary based on the institution's Certification and Agreement to the U.S. Department of Education (Department).

- 1. Daemen College has signed and returned to the Department the Certification and Agreement. Daemen College will use no less than \$2,506,436 of the funds received (\$4,928,222) under Section 314 (a)(2) of the ARP 2021 Supplemental Agreement for an Award to provide Emergency Financial Aid Grants to students.
- 2. Daemen College has received \$4,379,382 from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.
- 3. As of December 31,2021, Daemen College has distributed 100.0% (2,506,436) of the \$2,506,436 received for Emergency Financial Aid Grants to students under Section 314 (a)(2) of the ARP 2021 Supplemental Agreement for an Award.
- 4. Daemen College has an estimated **2,097** students eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 314 (a)(2) of the ARP 2021 Supplemental Agreement for an Award.
- 5. As of December 31,2021, a total of **1,222** Daemen College students have received an Emergency Financial Aid Grant under Section 314 (a)(2) of the ARP 2021 Supplemental Agreement for an Award.

6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 314 (a)(2) of the CRRSAA 2021 Supplemental Agreement for an Award.

Daemen College established a simple process for students to apply for Emergency Student Financial Aid under the CRRSAA Supplemental Agreement and the same process as used for the CARES Act distribution. An application was posted on the College's main COVID-19 information page on our website. A CRRSAA Emergency Student Financial Aid Committee, comprised of representatives from Financial Aid (Financial Aid Director as Chair), Student Affairs, Academic Affairs, and the Center for Diversity and Inclusion, scored each application based on a rubric. The scoring rubric included eight categories as identified in CARES Act guidance: Food, Housing, Technology, Course Materials, Child Care, Employment, COVID-19 related health concerns, and Death. Each category received a rating on a 1 to 3 scale with "0" signifying "not affected at all" and "3" signifiying "in dire need of support and resources." Student applications then received a total score from 0 to 24 (lowest to highest need). Tiers with corresponding monetary values were used to distribute funds based on total scores, as follows:
