### Why Paralegal Studies and Sustainability?

Today's legal and business world recognizes that sustainability is our future!

- Dow Jones Sustainability Indices are based on corporate economic, environmental and social performance with many corporate mission statements including sustainability and social responsibility.
- Tax laws are changing with new opportunities for carbon credits, cap and trade policies, conservation easements, renewable energy investments and brownfield development.
- There is a growing profession recognized by professional journals (Journal of Environmental & Sustainability Law, Sustainability Law and Policy) and new graduate programs focus on "green law" and sustainability.
- Business law changes encourage Benefit Corps, which measure progress through environmental and social initiatives.

Legal firms need to help clients anticipate and respond to changing environmental policies as well as take advantage of funding opportunities for sustainable development and renewable energy investment.

## Why Daemen College?

## Can I complete both majors in four years?
